The «Lucerne Academy for Human Rights Implementation» is a worldwide unique and varied human rights law program based in the heart of Europe at the University of Lucerne, Faculty of Law, Switzerland. The main topic of the 2024 Summer School is **«Business and Human Rights»**.

The Lucerne Academy offers participants an exciting, multifaced and intensive two-week program. It includes a comprehensive range of courses and various lunch seminars in the field of human rights as well as two excursions and further interesting event programs.

Participants are given the chance to learn and consolidate the theoretical and trial skills necessary to prepare for a career in defending human rights.

The Lucerne Academy for Human Rights Implementation ensures a high degree of academic quality as well as interaction between participants and academic staff.



Program Summer School 2024

Courses

In 2024 the Lucerne Academy provides participants **eight different courses** focused exclusively on human rights law of the European Convention on Human Rights and the UN Covenants on Human Rights. All participants take different classes of their choice, three of which are mandatory. In the regular classes, participants acquire necessary and fundamental theoretical knowledge. The classes are taught by distinguished professors and practitioners from around the globe.

The **lecturers of the courses** are, among others, **Prof. Dr. Sebastian Heselhaus** (University of Lucerne), **Prof. Dr. Olivier De Schutter, LL.M.** (University of Louvain, UN Special Rapporteur on extreme poverty and human rights), **Prof. Dr. Tyler Giannini** (Harvard Law School), **Prof. Dr. Markus Krajewski** (University of Erlangen-Nürnberg), **Prof. Dr. Felipe Gomez Isa** (University of Deusto (Bilbao)), **Prof. Dr. Christina Binder, E.MA** (University of Vienna, University of the Federal Armed Forces Munich) as well as **Dr. Gabriel Webber Ziero, LL.M.** (Senior Legal Counsel).

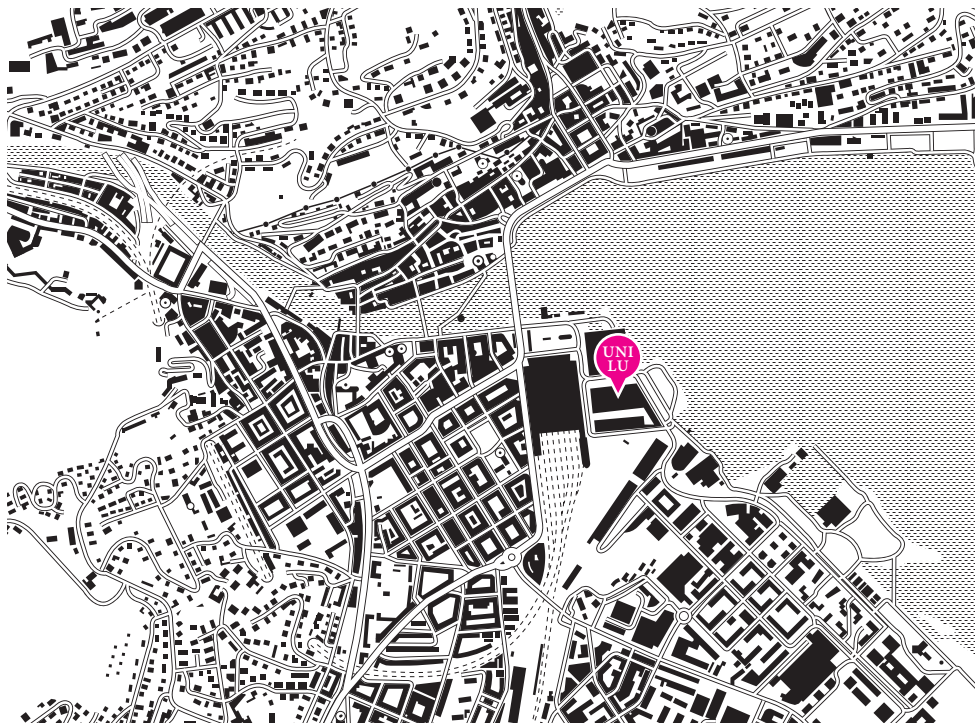
Lunch seminars

Furthermore, the Lucerne Academy offers participants **various lunch seminars**. During the lunch seminars, participants have the chance to learn directly from distinguished practitioners how to work with and implement human rights. In the lunch seminars, participants will receive practice-oriented knowledge and interactively discuss possible solutions to specific questions and topics related to human rights.

Excursions

The Lucerne Academy also offers participants two excursions, one to Geneva and one to Strasbourg. In **Geneva**, the participants will visit the European headquarters of the United Nations, as well as various NGOs. In **Strasbourg**, the participants will visit the seat of the European Court of Human Rights and the Council of Europe. During the excursions, the participants learn more about the organizations and the European Court of Human Rights and their specific roles and tasks. In addition, the participants interact with important NGOs and officials and acquire an insight into the practice of human rights implementation.

Participants can earn **seven (7) ECTS** credit points for the successful completion of the courses and lunch seminars. Participants, who successfully complete three out of eight courses and the lunch seminars, will all be awarded a Certificate of Completion.
