Teaser to the Keynote:

Better health is created in the communities we live in. However, local communities need appropriate national frameworks to thrive, and without global collaboration, even local health outcomes remain fragile. As Prof. Cyril Chantler rightly said, “Medicine used to be simple, ineffective, and relatively safe. It is now complex, effective, and potentially dangerous.” Thomas Zeltner will share his experience on why interprofessional collaboration is crucial in this context and highlight the key factors for success.

About Thomas Zeltner:

Thomas Zeltner is a Swiss physician and lawyer. He is the president of the Swiss Red Cross. He is also the founder and first chairman of the WHO Foundation in Geneva and Deputy Chair of the University Council of the Medical University of Vienna (Austria). From 1991 to 2009 Thomas Zeltner has been Director-General of the Federal Office of Public Health (BAG). In this function, he also represented Switzerland at the World Health Organization. He graduated with an MD and a Master's degree in Law from the University of Bern. Since 1992 he has been Professor of Public Health at the University of Bern.
