- Information on any breaks in your academic work or part-time employment and information on the net academic age (calculated from the date of your dissertation defense). We accept all reasons for breaks that are also acceptable to the Swiss National Science Foundation. (see <u>SNSF document net</u> academic age).
- Information on dissertation (subject, month and year of defense, title of dissertation, institution)
- Information on "habilitation" (month and year of habilitation, title of habilitation, institution)

3 Research

- Information on 5 publications or other significant research achievements most relevant to the position, at least 3 of which must have been published/accomplished in the last 5 years.
- List of publications (including books, all articles in peer-reviewed journals and in non-peer-reviewed journals, book chapters)
- Information on other relevant achievements (e.g. development of software, knowledge transfer, etc.)
- Information on embeddedness within the scientific community, including international research visits.
